CONFIRMATION AGREEMENT & CANCELLATION POLICY

This confirmation form must be returned within two weeks of receipt. Failure to complete and return this form may result in forfeiture of the space reserved. The cancellation deadline for this retreat is May 30, 2019. Cancellation before this deadline may result in a *refund of the \$150/\$200 registration fee*. Cancellation after May 30, 2019, will result in a *forfeiture of the \$150/\$200 registration fee*. Contact Coaches Outreach ASAP if you need to cancel (others cannot cancel for you). In most cases, we have a waiting list for each retreat and can easily fill your spot with a couple from the waiting list.

If you cancel *after* the deadline and there is no one on the waiting list to fill your spot, you *will incur a \$250 cancellation fee* (in addition to the \$150/\$200 registration fee forfeiture).

BIBLICAL DEFINITION OF MARRIAGE

Based on Holy Scripture (Judeo /Christian Bible) and the constant moral teaching of the universal Church:

Marriage — Coaches Outreach defines marriage as the exclusive, and conjugal “one flesh” union of one man and one woman, physically designed by God for procreation of a biological family, and in furtherance of the moral, spiritual, and public good of binding father (male born), and mother (female born), and child/children. (Genesis 1:27-28, Genesis 2:18-24, Matthew 19:4-9, Mark 10:5-9, Ephesians 5:31-33).

Coaches Outreach welcomes all divorced and remarried couples, recognizing that in our culture many marriages have resulted in divorce, for biblical and non-biblical reasons. Our marriage retreats focus on God’s best for your marriage today, with the goal of preparing your future for a marriage that honors Him and His intentions.

RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, & INDEMNITY AGREEMENT

In consideration of being given the opportunity to participate in any activities (“Activity”) of Coaches Outreach, for myself, my personal representatives, assigns, heirs, and next of kin: I hereby release, discharge, and covenant not to sue Coaches Outreach, its administrators, directors, agents, officers, directors, volunteers and employees, any sponsors, advertisers, and owners and lessors of premises on which the Activity takes place (each considered one of the releasees herein), from all liability, claims, demands, losses or damages arising out of or related to the Activity; and I further agree that if, despite this Release and Waiver of Liability, Assumption of Risk, and Indemnity Agreement, I, or anyone on my behalf, makes a claim against any of the releasees, I will indemnify, save and hold harmless each of the releases from any litigation, expenses, attorney fees, loss, liability, damage, or cost that may incur as a result of such a claim. I give Coaches Outreach permission to take and use photos, videos, stories, or any other recording of me or my likeness for promotional or other purposes.

I have read this Agreement, fully understand its terms, understand that I have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law, and agree that if any portion of this agreement is held to be invalid, the balance, notwithstanding, shall continue in full force and effect.
